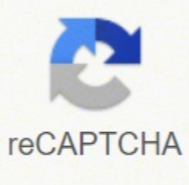




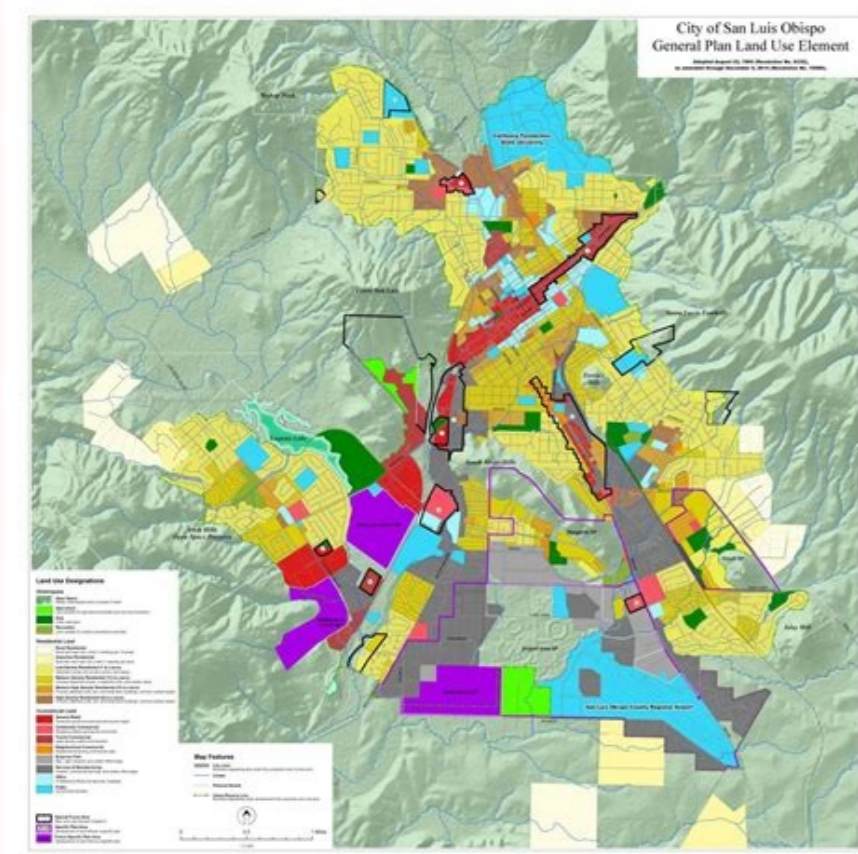
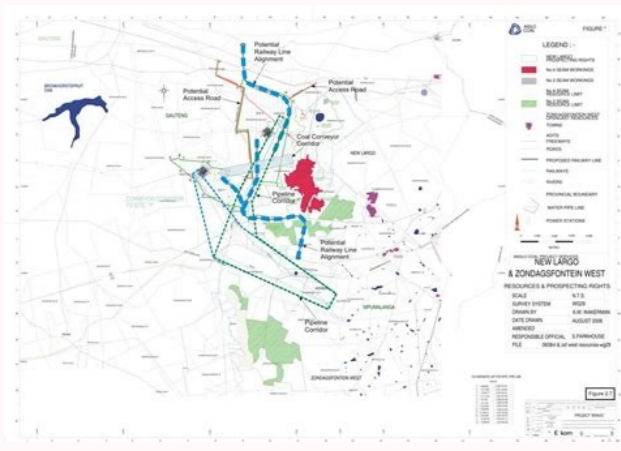

# Eir draft environmental impact report



The City of Oakland has released a final environmental impact report for a ballpark project in Oakland and for the development at the Howard Terminal downtown, without significant changes from the draft report previously released. You can read all 3,500 pages here. No major changes were made to the final report, as indicated in Chapter 2, although responses to the 400 comments submitted on the draft were added: "The project proponent did not submit any changes to the proposed project or to the variants analysed in the draft EIR. However, this section deals with new or updated information added to the public registry by the Project Applicant, the City or Port of Oakland (A "PortA") that the City has determined in relation to the Proposed Project, its approvals or requirements, or other information mentioned in the draft EIR. Although none of the updates discussed here represent changes to the proposed project or to the draft EIR that could lead to changes to the EIR project's environmental assessment under the EQF, the Municipality has decided that these changes warrant the disclosure of the response to comments in this document for the information of the public and project decision makers. "The release of the Final Environmental Impact Report is a milestone on our path to building a new waterfront basketball district that will create up to 18 acres of beautiful public parks, more affordable housing and good jobs for Oaklanders residents. The 3,500-page document is complete and exhaustive and guarantees the safety and environmental sustainability of the project. Completion of the EIR keeps us on track to bring the project to the final vote of the City Council in 2022 and takes us a step towards maintaining our A's rooted in Oakland. Firstly, the Oakland Planning Commission will conduct a public hearing on the final eIR on 19 January 2022 at 3 p.m. During the hearing, the Planning Commission considers whether the final EIR was completed in accordance with state law, it represents the independent analysis of the city and provides adequate information to decision makers and to the public on the adverse environmental effects of the proposed project, as well as the ways in which such effects could be avoided. After receiving a recommendation from the Planning Commission, the Oakland Municipal Council will consider the final EIR certification on a future hearing date, probably in February 2022.
